Data for Accountable and Transparent Action: Objective 1

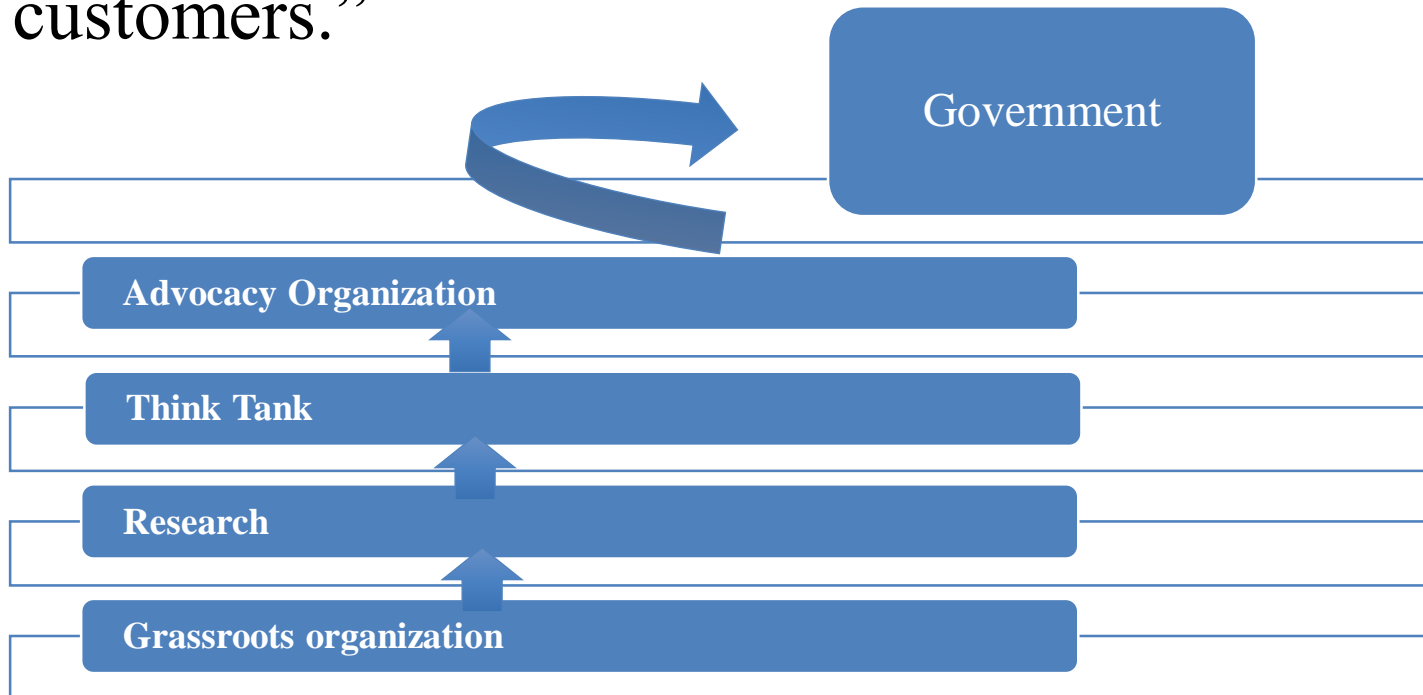
Improve the capacity of CSOs to identify, assess, analyze, and effectively communicate the evidence for policy making.

DATA Results: Near term

- Methodology for Data-Driven Policy Processes for CSOs is developed and applied
- Four thematic policy challenges addressed via Network Consortia
- Sixteen CSOs (from various sectors) engaged in data-driven policy interventions
- More than 100 CSOs improve their capacity in engaging in data-driven policy making at grassroots level
- Improved communication and cooperation between State and Civil Society on policy issues

DATA Results: Near term

- Gender equality mainstreaming in policy-formulation processes improved
- Positive Youth Participation boosted in local development processes
- Comprehensive Communication/media tools and products for effective policy communication
- Young scholars and fellows conduct at least 20 policy-related analysis
- Strong CSOs (at least five DATA Partners and 16 Network grantees) with capacity to effectively engage in policy and/or promote policy change

DATA Results: Long term

- New culture of data-driven policy and advocacy promoted
- The voice of civil society translates into policies due to the sector's improved capacity to produce well justified and sound evidence-based recommendations for policy input.
- The CSOs have sufficient skills and tools to effectively communicate to the decision-makers.
- The civil society organizations engage in effective cooperation with each other and their constituents within and across sectors.

DATA Results: Long term

- Armenia's civil society is able to embrace data-driven decision making.
- Demand and supply in data-driven decision making approach is fostered.
- CSOs' capacity to adopt nondiscriminatory, inclusive, and integrated approaches in decision making, is improved.
- Civil society strengthens their watchdog role and creates a new role of trusted advisor and policy advocate.

Vision of DATA program

The presence of a robust civil society is a necessary component of any well-functioning democracy: this activity will build the capacity of civil society to contribute to Armenia's stability and prosperity.
